

# Terms and Conditions - KPay Transaction Fee Rebate Offer

### **Promotion Period**

1. The Offer is valid from 14 March 2023 to 13 June 2023, both dates inclusive (Promotion Period).

## Who can enjoy the Offer

- 2. The Offer is exclusive to merchants who have successfully open a livi Business Account with livi using the exclusive livi promotion code [kpay#300] during the Promotion Period and with the same Business Registration Certificate number who
  - a. successfully apply a payment collection service at KPay Merchant Service Ltd. (KPay); or
  - b. is a KPay existing merchant and fulfil other conditions set out in these Terms and Conditions (Eligible Merchants).

# Who cannot enjoy the Offer

- 3. The Offer is not available if:
  - a. using a different Business Registration Certificate number to open livi Business Account and apply for KPay payment service; or
  - b. the applied KPay payment service cannot be completed and approved within the Promotion Period; or

  - d. fail to apply the exclusive livi promotion code [kpay#300] upon opening livi Business Account.
