

# DBS x KPay 中小企低碳獎賞 ("本優惠") KPay 條款及細則

#### 推唐期

 本優惠有效推廣期為由即日起至2025年6月3日(包括首尾兩日) ("推廣期")。

# 誰可獲享本優惠("合資格商戶")

2. 於推廣期內成功開立星展銀行企業賬戶並以相同號碼的商業登記證於KPay Merchant Service Ltd. ("KPay") 成功申請、批核並支付開戶費成為支付服務的新商戶為合資格商戶。

# 誰不可獲享本優惠

- 3. 本優惠不適用於下列情况:
  - a. 所申請之KPay支付服務未能於推廣期內完成核批;或
  - b. 現有KPay商戶,或於申請當月起計過去6個月內曾使用或取消由KPay提供的收款服務之商戶。

    - 100% transaction Merchant Discount Rate fee rebate on the first HK\$1,000 eligible offline transaction each month via KPay Smart POS Terminal (Starting from the 3rd month (the 91st day) after the merchant successfully applies for the KPay offline transaction service for 6 months)
    - ii. Qualified transactions include the use of Visa, Mastercard, UnionPay, JCB, American Express, Alipay (Hong Kong and Mainland China wallets), WeChat Pay (Hong Kong and Mainland China wallets), Apple Pay, Google Pay, Samsung Pay, BoC Pay, PayMe, Diners, and Discover.
  - b. Merchants who completed the SME Low Carbon Missions can enjoy rewards.
    - i. KConnect cash vouchers worth HKD 1,000 and could be used on the net purchase of KConnect software or system when the total cost reaches HKD 5,000.
